- 2- The licence and any certificate of renewal in force shall be displayed on the approved premises and the original shall be produced on the request of an Inspector appointed under the Drugs & Cosmetics Act, 1940.
- 3- Any change in the technical staff shall be forthwith reported to the Licensing Authority and/or Central Licence Approving Authority.
- 4- The licensee shall inform the Licensing Authority and/or Central Licence Approving Authority in writing in the event of any change in the constitution of the firm operating under the licence. Where any change in the constitution of the firm takes place the current licence shall be deemed to be valid for maximum period of three months from the date on which the change has taken place unless, in the meantime, a fresh licence has reen taken from the Licensing Authority and/or Central Licence Approving Authority in the name of the firm with the changed constitution.
